

PASSENGER TRANSPORT MANAGEMENT CPC EXAMS

WHAT IS IT?

Passing the CILT(UK) Level 3 Certificate of Professional Competence for Transport Managers exams will qualify an individual to act as transport manager for an operator in the road haulage or passenger transport industries, depending on which exam is taken. Exams are held at regular dates each year.

WHAT DO THE EXAMS INVOLVE?

The CILT(UK) Level 3 CPC for Transport Managers consists of two examinations, in the following format:

- **Paper 1 - Multi Format Response exam:**
 - 2-hour 'closed book' exam, consisting of 40 questions each worth 1 mark
 - Multi Format Response papers involve questions from across the entire Management CPC syllabus
 - This exam has a 70% pass mark
- **Paper 2 - Case Study Assessment exam:**
 - 2 ¼-hour 'open book' exam, consisting of 3 questions each worth up to 20 marks
 - This exam has a 50% pass mark

In order to be awarded the qualification, Learners must successfully pass both papers. Failure to pass either exam will require that only that paper must be re-taken

WHAT DOES IT COST?

Exam fees are as follows and candidates will only pay for what they need:

- **CILT(UK) Learner Registration fee (one off fee for all candidates)** £29.00 (VAT exempt)
- **Paper 1 - Multi Format Response exam** £57.00 (VAT exempt)
- **Paper 2 - Case Study Assessment exam** £57.00 (VAT exempt)
- **CILT(UK) Exam Proctoring Fee (for online exams only)** £28.00 per exam (VAT exempt)
- **Administration Fee** £40.00 per exam (including VAT)

This means a first time candidate taking both exams (paper-based) will pay £223.00, whereas a resit of one exam (paper-based) will be £97.00

WHEN ARE THE EXAMS BEING HELD?

Exams are either held online from candidates own location* or may be paper-based at our training centre.

- **March 2026:** Tuesday 3rd March 2026 (*last registration Monday 9th February*) **PAPER 1 - ONLINE ONLY**
- **April 2026:** Tuesday 14th April 2026 (*last registration Monday 23rd March*)
- **May 2026:** Tuesday 12th May 2026 (*last registration Monday 20th April*) **PAPER 1 - ONLINE ONLY**
- **June 2026:** Tuesday 9th June 2026 (*last registration Monday 18th May*)
- **July 2026:** Tuesday 7th July 2026 (*last registration Monday 15th June*) **PAPER 1 - ONLINE ONLY**
- **August 2026:** Tuesday 4th August 2026 (*last registration Monday 13th July*)
- **October 2026:** Tuesday 6th October 2026 (*last registration Monday 14th September*)
- **November 2026:** Tuesday 3rd November 2026 (*last registration Monday 12th October*) **PAPER 1 - ONLINE ONLY**
- **December 2026:** Tuesday 8th December 2026 (*last registration Monday 16th November*)
